## § 1194.21 Software Applications and Operating Systems

The administrative functions of the AudioCodes M3K Gateway may be accessed via a Command Shell interface that supports Secure Shell (SSH) and Telnet connections. This Command Shell interface is text-only, with no point-and-click operations.

**Note:** The physical terminals and terminal emulation software commonly used to administer the AudioCodes M3K Gateway are *not* AudioCodes products. The statements in this document assume that the AudioCodes M3K Gateway's administrative interface will be accessed via endpoints that comply with the applicable Section 508 requirements.
