**Product Description:** Avaya IX Messaging is a unified messaging and real-time communications platform designed to provide team engagement tools for the cloud-based worker. IX Messaging provides the ability to store messages in a variety of environments, including local stores, on premises email environments and cloud based email environments, including Office 365 email environments. It is Windows based and runs in a VMware environment.

For end users, both a browser-based interface and a TUI (Telephone User Interface) are supported. The conformance of the browser interface is described in the Chapter 2 responses. The conformance of the TUI is described in the Chapter 4 responses.
